Staff Report

Augerot expressed confusion about multiple versions of the Ordinance in circulation, noting a typographical error and some requested changes that had not been made.

Residents Richard Weber, Eileen Stark, and Arlene Merems provided comment, praising the general intent of the Ordinance but requesting further changes.

Fair Board member Trudy Overlin stated that the Fair Board still regarded this Ordinance as an overreach.

Fair Board member Craig Hendrickson asked if a Benton County resident who owns an alligator (an animal on the restricted species list) would have to move or remove their business from Benton County.

Wyse replied the individual could own the animal, just not display it publicly in the unincorporated portion of the County.

Deliberations

After discussion, the Board decided to continue the Public Hearing until the December 19, 2023 Board Meeting at 11:00 a.m. to resume deliberations on an updated redline version of the Ordinance based on testimony and information received today.
