## County's Greenhouse Gas Emissions & Climate Action Plan – Sean McGuire

Per the request by Members in August, Sean provided the annual presentation to Commissioners on Benton County's greenhouse gas (GHG) emissions goal, annual emissions report, and a general review of the Climate Action Plan. Those materials can be found on the County's <u>Climate Action homepage</u>. Members suggested that future presentations include tracking GHG reductions based on County expenditures.

#### Sustainable Materials Management Plan (SMMP) – Sean McGuire

Sean updated ENRAC on the SMMP process, next steps, timeline, and how the SMMP fits into the western Oregon regional waste management system. Both waste management and materials management systems are critical to the region's long-range efforts for sustainability. The County created an SMMP Task Force, and their Kickoff meeting will be October 21st.

## Shift Together to Rural Areas - Sean McGuire

County Finance and BOC staff continue to explore Seeds for the Sol to enter rural markets & communities. Sean will update & share opportunities for ENRAC to engage.
