These programs ensure that all children, regardless of background or circumstances, have access to essential oral health care. Dental sealants can prevent up to 80% of cavities on the chewing surfaces of back teeth. Addressing untreated cavities is crucial, as they can cause pain and infections that interfere with eating, speaking, playing, and learning—further impacting a child's overall well-being and ability to thrive. One key element in ensuring children have access to the appropriate restorative care is the follow up done after preventive care is provided in the school setting. Often times parents lack the resources or knowledge of options for their children, care coordination is a critical piece of the puzzle for improved oral health."

Directs the Oregon Health Authority to establish a grant program to provide financial support to certified dental sealant programs that promote and engage in oral health care coordination activities. Provides the manner in which the authority shall distribute grant funds to grantees.

SECTION 2. There is appropriated to the Oregon Health Authority, for the biennium beginning July 1, 2025, out of the General Fund, the amount of \$900,000 for the purpose of carrying out the provisions of section 1 of this 2025 Act.
